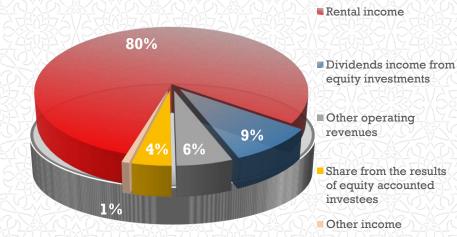

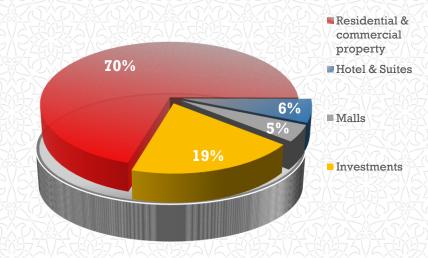

EBIT SEGMENT CONTRIBUTION



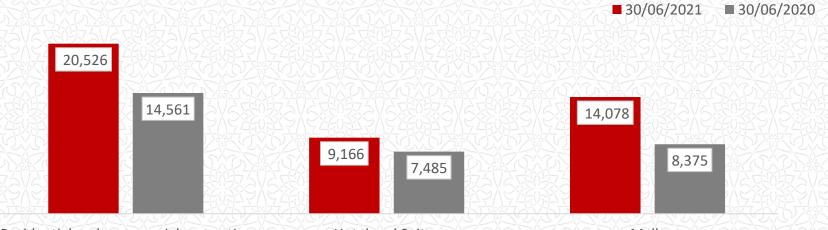
