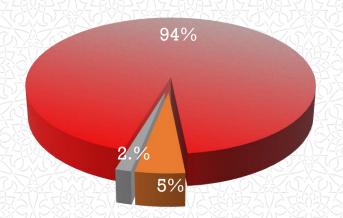

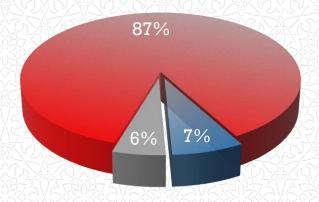
#### **REVENUE BREAKDOWN**
